Rally Advanced Excellent (RAE) Class: When entries are limited in the Rally Advanced and/or Rally Excellent classes, a club must designate a Rally Advanced Excellent class in the premium list. Dogs entered in this class would be entered in both Rally Advanced B and Rally Excellent B, and the combined entry fee for these two classes must be paid. Once the limit has been reached in either the Rally Advanced or the Rally Excellent class, the Rally Advanced Excellent class will be considered closed and any subsequent entries for this class will be rejected.

Rally Champion (RACH) Class: Dogs entered in this class would be entered in Rally Advanced B, Rally Excellent B and Rally Master class. The combined entry fee for these three classes must be paid. If due to entry limits an exhibitor cannot be entered into the Rally Advanced B, Rally Excellent B and Rally Master classes the <u>Rally Champion</u> class will be considered closed and any subsequent entries for this class will be rejected.

Ring Sizes: All rings will be 2,000 square feet (40x50)

**ALL ENTRIES MUST BE LEGIBLE, SIGNED AND HAVE A JUMP HEIGHT**, *if entered in classes that use jumps,* or they will be refused. Jump height order will ascend on Saturday and descend on Sunday.

ENTRIES ARE LIMITED and will be taken on a first come first served basis, (so get your entries in early). Crating Area is limited, X-pens, Pet Playpens will not be allowed at the trial site. Fire aisles **MUST** always be kept clear. No unentered dogs are permitted or allowed at the site. IPOC will charge a \$25.00 fee for a returned check.

Dogs should be present at least one-half hour before they are to be judged. The owner or handler is solely responsible for having their dog at ringside when it is due in the ring. Dogs not required for further judging may be excused.

A two-Day Trial Catalog in hard copy will be available for \$5.00 on the day of the trial. Electronic correspondence will be used to send your entry information and judging program. Please supply your correct email address. If you require a hard copy to be sent to your USPS address, please check the box on your entry form to say that.

### **Directions to the Trial Site**

**From I-4:** Take Exit 27 (Polk Parkway – Highway 570) to the first exit (Airport Road) approximately three miles. Turn right onto Airport Road, go to the second light (Drane Field Road), and turn left. Then stay on Drane Field Road to Century Boulevard, which will be the first street (on the left) after the circle (across from the firehouse station). Turn into the industrial complex, then use the third driveway on the left. The IPOC building is straight ahead.



**From Highway 60:** Take Highway 60 to S. County Line Road. Go approximately five miles right on Drane Field Road. Stay on Drane Field road for approximately three miles to Century Boulevard, which will be the first street (on the left) after the circle (across from the firehouse station). Turn into the industrial complex, then use the third driveway on the left. The IPOC building is straight ahead.
